In accordance with the contract requirements with the Lake County Community Economic Development Department (LCCEDD), the Northwest Indiana Reinvestment Alliance (NWIRA) hereby submits the Annual Report for program year September 1, 2022 to August 31, 2023. This report highlights programs both existing and new, Outreach Efforts, Financial Education, Housing Counseling, Small Business Education, and initiatives designed to Affirmatively Further Fair Housing in our local community.

During this contract year, NWIRA continues to address the housing issue. We are in partnership with Indiana Housing Community Development Authority (IHCDA) for their Indiana Homeowner's Assistance Fund (HAF) program to assist with applications for monetary assistance for homeowners with mortgage payments, property taxes and homeowners' insurance premiums. We are a member of the National Community Reinvestment Coalition (NCRC) and sub-grantee for their U.S. Department of Housing and Urban Development (HUD) Foreclosure Counseling program. NWIRA is an HUD Certified Counseling Agency with Certified Counselors providing services to clients at the NWIRA office in partnership with agencies and organizations throughout Northwest Indiana. Housing and lending initiatives are addressed through the Lake County Housing Taskforce, the Northwest Indiana Banker Community Council, and the Lake County Land Bank Authority. Our agency organizes and facilitates meetings, workshops and seminars that provide an on going dialogue to ensure quality affordable housing, safe and sound fair lending practices, and small business training and development. The Alliance continues to partner with First Financial Bank to provide loans to small businesses for startup and business development.

In keeping with our mission to provide awareness and education, NWIRA provides First Time Homebuyer's Education, Pre and Post Homeownership Counseling, Money Management Counseling, Financial Literacy Workshops and Coaching, Small Business Training and Development Workshops. As a HUD organization we support various financial workshops offered in partnership with our Northwest Indiana Banker Community Council members. We continue to partner with Northwest Indiana Community Action (NWICA) on lending opportunities for residents and small businesses, Individual Development Account (IDA) program, and a Payday Lending Alternative program, and additional programs: Asset Building and Tax Preparation (VITA), Family Development, Home and Community Based Services.

NWIRA is also a long-standing member organization of Prosperity Indiana that builds vital communities and resilient families throughout the State of Indiana. Prosperity Indiana's membership allows citizens to connect with community economic development practitioners, and access to resources to help further their work in communities. Members gain access to exclusive services, including policy advocacy, training, and consulting services.

NWIRA intends to continue to develop new programs and expand services for the residents of Lake County. We value and appreciate the partnership and the opportunity to support the Lake County Community Economic Development Department (LCCEDD) in its efforts in ensuring Fair Housing, Fair Lending, and Equal Opportunity for all Lake County residents.

COMMUNITY REINVESTMENT ACT (CRA)

The Northwest Indiana Reinvestment Alliance (NWIRA) is a member organization of the National Community Reinvestment Coalition (NCRC) based in Washington D.C. CRA is critical to the development of low to moderate income communities. Passed by Congress in 1977, the Community Reinvestment Act (CRA) states that regulated financial institutions have continuing and affirmative obligations to help meet the credit needs of the local communities in which they are chartered. NWIRA conducts annual meetings with each of its NWI Banker Community Council members regarding their Community Reinvestment obligations, and activities in Lake County. CRA activities of banks are mandated by federal regulations which include levels of lending, investments, and services in low to moderate income communities. Currently lenders opt to develop strategic plans in conjunction with neighborhood organizations to satisfy the communities' credit needs in their assessment area. Community groups can also be involved in the evaluation process by commenting on lenders' evaluation by the regulators.

Lake County communities, like others around the country need financial support to maintain the quality of life of the residents. NWIRA provides workshops, seminars and activities in conjunction with the NWI Banker Community Council, and Lake County Housing Taskforce throughout the year to educate the sixteen (16) cities and town officials, employees and residents that receive Community Development Block Grant (CDBG) funds from the Lake County Community Economic Development Department.

NATIONAL FORECLOSURE MITIGATION COUNSELING PROGRAM (NFMC)

NWIRA has received through the National Community Reinvestment Coalition (NCRC) grants for the past sixteen (16) years to conduct Foreclosure Mitigation Counseling.

Default Counseling Training sponsored by Neighbor Works America and NCRC have been completed by NWIRA Counselors. There are a total of four (4) Certified Counselors on the NWIRA team. Counselors have also received certification and continued education through the Chicago Federal Reserve Bank, Hope Loan Portal, Housing and Urban Development, Indiana Housing and Community Development Agency, National Community Reinvestment Coalition, and Neighbor Works America.

Counseling is provided at no cost to the client at the NWIRA office. Bi-lingual services are available. Outreach is on-going in partnership with a variety of agencies and organizations throughout Northwest Indiana, by way of social media, newspapers ads, radio, workshops, website, sponsorships, and seminars. Information detailing the programs provided by the Alliance has been distributed countywide through seminars, job fairs, government offices, agencies organizations, churches, and NWIRA website, www.nwira.org. All information is available in English and Spanish. NWIRA provides counseling to all Indiana Counties and Southern Cook County, Illinois residents. The following data reflects clients served reported on the HUD 9902.

HOUSING COUNSELING PROGRAM

The NWIRA is a U.S. Department of Housing and Urban Development Certified Housing Counseling Agency that provides comprehensive Homeownership Counseling. Working in partnership with housing providers, lenders, realtors, and community organizations, workshops are conducted to educate potential homebuyers. Participants are taught the benefits of homeownership, the cost involved in purchasing a home, and the responsibilities of homeownership.

Housing counseling classes are designed to provide education to those who have never purchased or have any knowledge of the home buying process. They are structured to increase the understanding of the home buying process and particularly beneficial for those having credit challenges. A mandatory eight (8) hours of classroom participation is required to receive the HUD certificate. Private consultations are encouraged for assistance in becoming credit worthy. The Alliance in partnership with lending institutions, community-based organizations, United Neighborhoods Inc., City of East Chicago, and the Lake County Community Economic Development, provide information on allowing residents the opportunity of applying for down payment assistance.

FINANCIAL LITERACY EDUCATION

Financial Literacy Education and Coaching is a very important part of the work the Alliance provides through one-on-one counseling sessions, and classes. In the aftermath of the "Housing Crisis", individuals need services that will help them recover from the loss of income, and the need to increase their credit scores in order to maintain a healthy and safe financial lifestyle.

NWIRA uses Financial Literacy Education curriculum created by the FDIC to help adults enhance their money management skills, and to create positive financial relationships. The target population is low to moderate income adults, those who are unbanked, experienced a hardship, or anyone that wants information to improve their financial lifestyle including those who may have been under served by local lenders.

The Northwest Indiana Banker Community Council (NWIBCC) was organized by the Northwest Indiana Reinvestment Alliance (Alliance) in 2008. The NWIBCC is a collaborative effort that brings banks, housing and community development specialists, public and private agencies, and non-profit organizations together to address the obligation of lending institutions to participate and support the fair lending portion of the Fair Housing law, Title VIII of the Civil Rights Act of 1968.

Through this partnership, the Council strives to educate, develop new initiatives and support projects and programs already in place to improve community development and economic growth that will enhance the quality of life for Lake County residents. The NWIBCC operates in the same manner as the NCRC National Banker Community Collaborative Council. This NWI Council has been recognized as the first local Bankers Council in the country.
